with conducting and implementing assessments is a MUST.

- Responsible for ensuring that ALL supervision is conducted in a professional and ethical manner and
 this must be modeled for all staff by the Director. The Lead BCBA will also ensure that each client
 receives the appropriate amount of supervision and that supervision be tailored to each client's
 individual needs.
- Assists in ensuring continuity and integration of behavioral services throughout all disciplines using
 positive collaborative communication
- Collects, inputs and revises individual's behavior programs and acquisition skills as needed
- Assists in ensuring staff are trained in individual's behavior program, reactive strategies, and positive reinforcement
- Monitors staff in all settings to ensure compliance with regulations
- Provides constructive feedback to staff and individuals through positive interactions, role modeling, and mentoring
